Air Canada immediately engaged the IAMAW in discussion and we were able to secure two (2) additional arbitration dates for 2020, December 10th and December 21st. These much needed arbitration dates will be used to hear outstanding national grievances. The parties have agreed to Arbitrator Christine Schmidt.
